- 2) I have read, understand, and agree to the Pend Oreille PUD's current Electric Service, Rates and Credit Policy, particularly Section 7.3 Advanced Meter Opt-Out. I agree that my account will be assessed a one-time Field Service Fee and a monthly Advanced Meter Opt-Out Fee in accordance with Pend Oreille PUD's current Schedule of Administrative charges.
- 3) I understand that my meter will be manually read by the PUD four times per year and that it will be estimated on off months. - 4) I understand that I will not be able to receive any other enhanced services or benefits that the advanced metering system may provide such as: verification of outages and outage restoration, detailed consumption data for monitoring usage patterns and identifying energy waste, and pre-pay metering.
