## Ducted Air-Source or Variable Speed Heat Pump Project Installation Form

### Eligibility

- This rebate is available for residential customers within Pend Oreille PUD's service territory.
- Available for existing single-family and existing manufactured homes.
  - For qualifying conversions to an ASHP or VSHP, existing heating system type must be an electric forced air furnace, with or without air conditioning.
  - For an upgrade to a VSHP, existing heating system can be a DHP, ASHP, Zonal electric, Wood/Oil/Propane/Gas, or no existing heating.
- Heat Pumps must be AHRI rated and meet current federal minimum standards for HSPF2 and SEER2. *If the unit only has an HSPF and SEER value, please contact the utility for verification of eligibility.*
- Installations must comply with all applicable codes and regulations. Rebate not to exceed cost of invoice.
