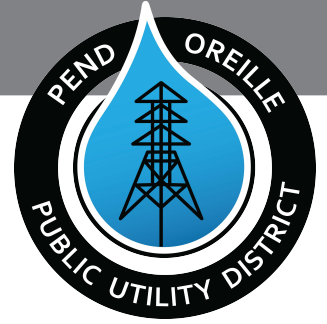

Qualifications:

1. Home **MUST** have an existing electric forced air furnace or air /ground source heat pump.
2. Must include a copy of the receipt showing manufacturer, model number, purchase date and price.
3. Smart thermostat **MUST** be listed below and have 7-day programmable or learning-based scheduling:

ecobee	ecobee 3 or 4, ecobee Smart Thermostat with Voice Control (or ecobee 5), (NOT ecobee Lite)
Nest	Nest Learning Thermostat/3rd Generation, Nest Thermostat, NestE

Bryant	T6-WEMO1-A

4. Built-in occupancy sensor with detection set to "on".
5. If the thermostat controls a heat pump, it must be programmed to control a heat pump.
6. Smart thermostat must be Wi-Fi enabled, with remote access.
