How to Take a Speed Test


Add 1. To take a speed test in the Broadband Navigator[™], zoom to your address by using the search bar or zoom F tools.

- 2. Select 'Take a Speed Test' in the 'Connectivity Hub' pane in the bottom left corner of the application.
- 3. A window will appear where you can select if you are on a VPN, mobile/wireless network, or if you are using your network heavily for video streaming or gaming.

- 9. The Broadband Navigator[™] will automatically e-mail the user after 24 hours with a link to take another speed test until three speed tests have been taken in compliance with BEAD guidelines.
 - a. If the user's current plan speeds are below 100/20, the user will not be required to take additional speed tests.
- 10. The state will use the median result of three speed tests, taken on separate days, to identify service levels.
