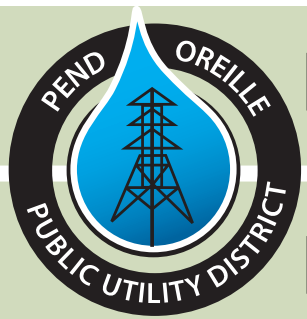

NOXIOUS WEED CONTROL

Since spring has sprung, we are on our way to warmer weather and the first of this year's weed seeds are on the move. To help prevent the spread of noxious weeds throughout the year, avoid traveling through weed-infested areas with ATVs and other off-road vehicles. To avoid bringing weed seeds into new areas, it is important to be cautious when taking vehicles off-road as seeds easily get caught in the frames and tires of vehicles and can blow away or fall out in a new location. It is advised to thoroughly wash your vehicle after being off-road. 2023 Annual Report

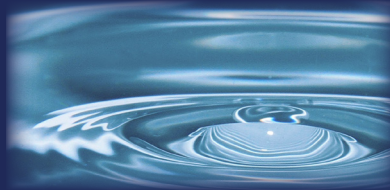
The PUD's 2023 Annual Report is now available and can be found on our website by visiting the main page or utilizing this link: [2023 Annual Report](#).
