ARE YOU CONSIDERING ROOFTOP SOLAR?

Approximately 30 PUD customers have additional generation beyond the metered power they receive from us. One of these types of generation is rooftop solar. A rooftop solar installation at your residence or business could be worth the investment, but it is a complicated matter that needs to be thoroughly reviewed before making a decision.

The PUD recommends you shop around and get quotes from 3-5 different companies and review agreements carefully. Ask questions about the terms, duration and how the companies benefit from your purchase or lease. Make sure the company provides you information about any available tax or rebate incentives.

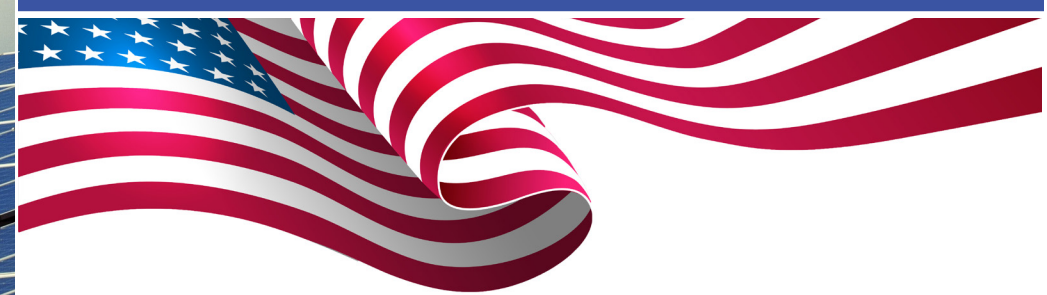

Wood Pole Test & Treat Program Gears Up

You may see Wood Pole Test & Treat contractors in your area starting mid-September through October. Contractors are testing PUD poles for integrity so that we can appropriately maintain the system and provide reliable service. You'll likely see crews in the southern portion of the county, specifically south of Diamond Lake.

The contractor crew has PUD signage on their vehicle, wears safety vests and hard hats, and carries identification. You may also see them driving an ATV (pictured above). If the contractor is accessing private property to inspect PUD equipment, they will first knock on the door to identify themselves. The pole test and treat process involves the contractor drilling a hole in the pole, testing it, installing a metal tag and taking pictures for inventory purposes.
