Wood Duck Boxes

Wood ducks and other waterfowl typically nest in large tree cavities adjacent to wet habitats that provide sufficient food. Once threatened with near-extinction in the early to mid-20th century, these birds have experienced a healthy population rebound, in part due to nest boxes creating new nesting opportunities. The PUD maintains over 35

The PUD maintains over 35 waterfowl nest structures as part of the Box Canyon Hydroelectric Project license compliance efforts. The PUD offers technical support to local groups and individual landowners that are interested in enhancing waterfowl nesting habitats in shoreline areas located within the Box Canyon reservoir.
