# Pend Oreille PUD Board Expands Low-Income Programs, Approves Advanced Meter Opt-Out Fee

**NEWPORT, WA** – The Board of Commissioners for Public Utility District No. 1 of Pend Oreille County (PUD) convened for a regularly scheduled meeting on April 1, 2025, at the PUD's Newport office. Key actions from the meeting included:

## **Expansion & Changes to Low-Income Assistance Programs**

The PUD has several programs for customers with a household income at or below 80% of the area median income (AMI) or 200% of the federal poverty level. The Board approved the following changes to low-income assistance programs:

- **Senior Discount Increase**: The monthly senior discount will increase from \$5 to \$10 per month.
- **Veteran Discount**: A new monthly discount will be available to honorably discharged veterans who qualify.
- Neighbors-in-Need Program Expansion: The Board expanded eligibility for the Neighbors-in-Need assistance program by removing the requirement that customers must be facing disconnection due to non-payment. Removing this requirement allows the PUD to be more proactive in awarding those customers facing hardship a \$250 grant toward their electric bill. The Board approved a \$12,500 contribution to the program this year.

# **Advanced Meter Opt-Out Fee**

Commissioners approved a service fee for those customers wishing to opt out of advanced meter installations. Customers who choose this option will pay:

- A one-time fee of \$100 for opt-out processing.
- A monthly \$30 fee to cover manual meter readings conducted quarterly.

If a manual read is not performed in a given month, bills will be based on estimated usage.

#### **Electric System Line Extension Fees and Electric Vehicle Charging Fees**

• **Line Extension Fees**: Commissioners approved adjustments to electric system line extension fees. These fees, which are updated annually, apply only to new customer connections and are separate from existing customers' electric usage rates.

• **EV Charging Fees**: The Board approved the installation of a fee for the PUD's Metaline Falls electric vehicle (EV) charging station. The rate will include a \$1 per session fee and a \$0.47 per kWh energy charge. The PUD currently operates two EV charging stations: one in Newport (sponsored by the Newport Chamber of Commerce) and one in Metaline Falls (currently unsponsored).

#### **Other Items**

The Board accepted the high bid of \$8,523.72 for the PUD's surplus 2007 Ford F-150 Crew Cab truck.

#### **Next Board Meeting**

The next regularly scheduled Pend Oreille PUD Board meeting will be held on April 15, 2025, at the PUD's Newport office, where the full minutes from the April 1 meeting will be reviewed and approved.
