## **AUTHORITY**

As provided in The Revised Code of Washington (RCW) section 54.24.080 the Commissioners of the Public Utility District No. 1 of Pend Oreille County (PUD) have the power and are required to establish, maintain, and collect rates or charges for services supplied by the PUD. The rates and charges shall be fair, nondiscriminatory, and adequate to provide sufficient revenues.

Utility Services Line Extension and Utility Service Regulations fees are designed to provide a fair and consistent method for providing Utility Services while adequately recovering costs. As new methods are developed and costs change, the PUD will review and adjust fees during the PUD's annual budget cycle, or as needed.

# 1. ELECTRICAL SYSTEM FEES AND CHARGES

The customer shall pay all costs and fees in advance, including, but not limited to the costs of permits, easements, clearing and any other costs to provide service.

## 1.1. APPLICATION FEES

Each applicant must submit a non-refundable Application Fee.

If an applicant applies and submits Application Fee payment for both an electrical and standard class fiber connection at the same time, a discount of \$150.00 will be applied.

The Application Fee will be credited against paid service extension fees.

## 1.1. TRANSFORMER CONTRIBUTION FEES

The table below lists the transformer contribution fees.

Note: Transformer Contribution Fee will be one-half the prices listed above for use of previously installed existing transformers.

## 1.2. SECONDARY SERVICE CONNECTION FEES

The fee reflects the minimum charge required for a Residential, Commercial or Irrigation connection to the PUD's high voltage electrical facilities. For Current Transformer (CT) services, the PUD provides the meter base, current transformers, and rain-tight enclosures, the cost of which is included in the connection fee.

## 1.4. PRIMARY SERVICE CONNECTION FEES

Service extension requests that are in excess of 150 feet from existing, high voltage facilities require that a primary line extension be constructed. The table below lists the appropriate primary service connection fee.

## 1.5. PRIMARY EXTENSION FEES

Service extension requests that are in excess of 150 feet from existing, high voltage facilities require that a primary line extension be constructed. The table below lists the appropriate fee schedule for single and three-phase primary line extensions. A Span is defined as the distance between two adjacent poles. All per foot charges are based upon measurement from the nearest wood pole, underground transformer, or underground junction box.

## 1.6. INDUSTRIAL EXTENSION FEES

Line extension fees will be determined for industrial applicants on a case-by-case basis whose load requirements necessitate the installation of new electrical facilities to provide a minimum of 500 kVA capacity.

## 1.7. ADDITIONAL SERVICES FEE SCHEDULE

Specific costs either referenced but not shown elsewhere or necessary for the PUD to recover when services to be provided are beyond the scope of the PUD's distinction of the typical line or service extension are listed below.

Note: Switch Cabinet Fee will be one-half the prices listed above for use of previously installed existing switch cabinets.

The above schedules and fees strictly apply to normal line extensions that can be constructed. Abnormal conditions that can cause difficult construction shall invalidate the schedules. These include, but are not limited to, terrain, environmental concerns, excessive rock, non-standard voltages or equipment, special permits, hydrography considerations, etc. PUD engineers will provide an estimate based upon the projected materials and labor to complete the project under the extenuating circumstances. The PUD shall have sole authority and final determination of the applicability of the schedules and the cost estimates for construction when it is determined that the fee schedules do not apply.

\*Area Light Installation: Area lights will only be installed on PUD poles. If pole installation is needed, or if all necessary electrical facilities are not within 200 feet of intended light installation, additional line extension fees will be required.

## 1.8. FACILITY MODIFICATION FEES

The PUD will furnish its best estimate of actual costs that will be incurred to modify, relocate or upgrade the service; which estimate shall be binding on the PUD provided that the request was not altered from the modification depicted in the quote at the customer's request. There shall be no later true-up to actual cost incurred. This fee shall include engineering, material, labor, professional services, permits, overheads, and similar costs.

## 2. COMMUNITY NETWORK SYSTEM FEES AND CHARGES

The customer shall pay all costs and fees in advance, including, but not limited to the costs of permits, easements, clearing and any other costs to provide service.

### 2.1. APPLICATION FEES

Each applicant must submit a non-refundable Application Fee.

If a prospective new customer applies and submits Application Fee payment for both an electrical and standard class fiber connection at the same time, a discount of \$150.00 will be applied.

The Application Fee will be credited against paid service extension fees.

### 2.2. FIBER SERVICE CONNECTION FEES

The PUD will furnish its best estimate of actual costs that will be incurred to extend broadband facilities to serve the new circuit, which estimate shall be binding on the PUD provided that the build was not altered from the route depicted in the line extension quote at the customer's request. There shall be no later true-up to actual cost incurred. This fee shall include engineering, provisioning, customer premise equipment, vehicles, installation equipment use, fiber optic cable, poles, conduit, trenching, labor, payroll overheads, and similar costs. The cost estimate may also include the cost of previously laid conduit for which cost recovery was not previously received.

The PUD will charge an Electronics Connection Fee for the provisioning of electronics for all Standard Class Service connection requests. This charge will appear on the first billing statement for the account, unless the fee was paid along with the new circuit request fee.

### 2.3. WIRELESS SERVICE CONNECTION FEES

New service requests will be made by the Retail Service Provider (RSP). The PUD will provide the WiFi Installation Kit to the RSP. The PUD will bill the RSP for the Installation Kit fee. The Installation Kit charges are applicable for the initial installation of electronics at a premise. Replacement of equipment after the initial installation date will also be subject to the Installation Kit fee, unless the equipment is covered by the manufacturer's warranty.

### 3. WATER SYSTEM FEES AND CHARGES

The customer shall pay all costs and fees in advance, including, but not limited to the costs of permits, easements, clearing and any other costs to provide service.

#### 3.1. APPLICATION FEES

Each applicant must submit a non-refundable Application Fee. The Application Fee is for all types of new installations, except for subdivisions, developments, and industrial parks, which will have a development Application Fee per connection, as solely determined by the PUD.

The Application Fee will be credited against paid service connection fees.

#### 3.2. SERVICE CONNECTION FEES

Customers in the County of Pend Oreille who desire water service from an existing water system must pay the full cost for attaining such service. The PUD will provide an estimate to the customer including all applicable charges. Once the plan has been approved by the PUD, the customer must pay the estimated cost and the System Connection Fee prior to the commencement of construction.
